

- **1.2** "Author" means the person who created the trust by "settling" a sum of money or item of property on trust for the beneficiaries and amended for time to time.
- **1.3 "Trustees"** means and includes the Board of Trustees as described in these presents, and these Trustees, as appointed, nominated by President of Trust.
- **1.4** "Office" means registered office/ project office of the Trust as described in clause 2 of this Trust Deed.
- **1.5** "Beneficiaries" means the public at large (including entities) for whose benefit the trustee holds the trust property.
- **1.6** "**Property**" means Property of the Trust or Trust Fund.

2. NAME, OFFICE AND AREA OF OPERATION:

The name of the trust shall be "AROGYAM SHAKTI FOUNDATION". The trust's registered office presently shall be at 1/4197, Ram Nagar Extn. Shahdara, Delhi- 110032. However, the trustees may change it from time to time by passing a resolution in the meeting of Board of Trustee on the basis of majority decision. The term Trustee shall mean the trustees of the said "AROGYAM SHAKTI FOUNDATION". Area of operation of trust shall be ALL OVER IN INDIA.

3. OBJECTS OF THE TRUST TO BE PURSUED:

The main trust area of activities and objectives of the Trust shall be to provide higher and further technical education, organize and take-up health facilities, women empowerment programs, self employment in agriculture sector, pollution prevention, social awareness, cow protection, running & maintenance of Gaushalas, child welfare for human development in rural areas and provisions of all the basic needs of a person to lead a normal life at affordable costs to the general public without any profit-making motive or to have any other form of gain by so doing Without affecting the generality of the above-mentioned objectives, the specific objectives to be achieved and activities to be undertaken are:

To promote, encourage, support, assist, advance and aid education and medical activities by promoting schools, colleges, university(s) for pre-primary, primary, secondary, undergraduate, post-graduate, doctoral, post-doctoral, vocational or otherwise in various branches or fields of education and to promote hospitals, blood banks, stem cell bank, placenta bank, Nursing homes, healthcare services for treating any ailment, illness, disability, disorder or disease at national and international level.

- i. To promote, encourage, assist, support, facilitate, aid, the training, placement and service sector activities required in various fields of life, life supporting activities in every aspect in rural, urban and metro areas, for developing various skills like leadership, entrepreneurship, technical, non-technical, political, social, sports and agricultural, arts, culture, craft and all other areas which are responsible to make the life more comfortable, by utilizing the direct or indirect potential of unemployed or employed, skilled, semi-skilled and un-skilled manpower and meeting the requirements of appropriately trained manpower in quality and quantity on a sustained and evolving basis as required by society at national and international level.
- ii. To promote, encourage, support, assist, advance and aid water and soil conservation, ground water recharging, storage and its distribution activities by

To establish, promote, open, setup, run, maintain, manage, operate, support, aid, help or assist schools, colleges or any other institution, organization, association or body, engaged in education or training (pre-primary, primary, secondary, undergraduate, post-graduate, doctoral, post-doctoral, vocational or otherwise), in various branches or fields of commerce, science, legal, medicine, engineering, economic, industrial, commercial, management, civil, architectural, literature, art, fine arts, performing arts, craft, technical or such other branch of education in India, and to give assistance to such schools, colleges or institutions, by way of loans, endowments, donations, grants, contributions, gifts and other means.

All the activities of the Trust shall be non-profitable and shall be done on a "no profit - no loss" basis.

4. TRUSTEE:

The board of trustees of the trust may at any time appoint any person or nominee of any organization as "trustee" for the term of maximum 2 years each. The casual vacancy or vacancy caused by retirement after the expiry of term of two years in the office of Trustee shall be filled by the Author of the trust. Any trustee retiring on expiry of said term of two years may be reappointed by the Author for further term of 2 years.

5. BOARD OF TRUSTEES:

Board of Trustees shall mean and include all trustee & maximum twelve Trustees. Board of Trustees shall constitute of not less than 2 (Two) but not more than 12 (Twelve) members.


6. DISQUALIFICATION OF THE TRUSTEESHIP::

- (i) if he or she has been found to be of unsound mind by a court of competent jurisdiction.
- (ii) if he or she by reason of mental or bodily infirmity has become incapable of acting.
- (iii) if he or she ceases to be a nominee of the organization.
- (iv) If he or she fails to attend three consecutive meetings of the Board of Trustees without just and sufficient cause and without prior intimation to the Author of the Board of Trustees;

7. POWER OF AUTHOR / PERMANENT TRUSTEE:

The power of Author / Permanent trustee shall be as follows:

- (i) To appoint, re-appoint, nominate Trustee.
- (ii) Author may appoint one or more secretaries, supervisors, clerks & other officials, employees, servants & contractual retainers & fix their remuneration.

8. FUNDS OF THE TRUST:

The funds of the Trust shall comprise:

- (a) Donation received from Philanthropists.
- (b) Endowments in favor of trust.
- (c) Grants from Central and State Government, Corporations and other statutory bodies and Institutions or Individuals from India.
- (d) Income from properties of the Trust.
- (e) Donations received from general public and Institutions.
- (f) Fees / Funds / Sponsorship amount received against meetings, conferences, training programme, rallies, Get together programme etc.
- (g) Any other income which may accrue in the working of any other institution controlled by the Trust.
- (h) Donations/Gifts received from individuals, Institutions organization foundations.

9. (1) POWERS TO FRAME RULES:

- a. For the conduct of their own meetings and business.
- b. For facilitating and carrying out of the objects of the Trust.
- c. To appoint sub-committees, advisory or Governing Bodies for all or any one of its managing institutions and they may delegate their powers to such bodies or others or to some of their members on such terms and conditions as they deem fit.
- d. To employ the necessary staff, take disciplinary actions, to terminate their services, regulate their service conditions etc.



- g. To decide the salary, pension, provident fund, honorarium, travelling expenses etc. for trustees, subcommittee members, advisory committee members, Governing body members, officers & staff etc.
- h. To decide appropriate Remuneration / honorarium to the trustees for their duties by the author or the Author of Trust.

9.(2) THE TRUSTEES MAY AND ARE HEREBY EMPOWERED TO:

- a. Obtain and secure in the name of the Trust any moveable/immoveable properties by Purchase, Gift, lease or grant and to own and possess the same to sell.
 Mortgage, or lease out the same, provided in case of purchase or sale of properties the consent of majority of the trustees has been obtained.
- b. Construct any building, any religious building and orphanage and improve, alter or repair any building which may be acquired in the name of the Trust.
- **c.** Raise funds and receive donations if necessary for carrying out the progress and objects of the Foundation.
- d. Incur necessary expenses for carrying out the aims and objects of the Trust.

10. VOTING PATTERN:

Every resolution or question submitted to a meeting shall be decided by a majority of votes of the trustees present at such meeting & voting on the question. The Permanent trustee shall have 2 votes & the Trustees shall have one vote each, but in the event of an equity of votes, the **Author** of Board of Trustees

Provided however that with the specific prior consent of the Author in writing the quorum for a meeting shall be deemed to have been constituted, even in the absence of the Author, but no business at such meeting shall be transacted, other than consented in writing by the Author. Provided further that any resolution passed in the meeting of the Trustees, wherein the Author was not present may be reconsidered by him and altered in the subsequent meeting/s.

Trustees shall not have power to cancel, amend or alter any provisions made in this quorum.

12. ACCOUNTS AND AUDIT:

The Trustees shall maintain true and correct accounts of all receipts and payments and dealings in regard to the trust property and shall also maintain the correct record of their meetings and deliberations. Accounts shall be audited every year. The accounting year shall be from 1st April to 31st March of every succeeding year.

13.BANK ACCOUNT

Bank account of the trust may be opened in any nationalized, scheduled, cooperative or private bank(s) in India. The bank account of the trust shall be jointly operated by Author / trustee / office bearers as decided in the Board of Trustee.

15. UTILIZATION OF TRUST PROPERTY:

If the income from the Trust property in a particular year is not fully utilized, the unspent income, subject to the applicable provisions of the Income Tax Act, 1961, shall be carried over to the next year or years and spent in such subsequent year or years for achieving the objects of the Trust.

16. BENEFITS OF THE TRUST:

The Benefits of the Trust activities in terms of the educational, training and related services it provides shall be available to all Indians, irrespective of caste, creed, race age, sex, or religion except where the benefits are to go to welfare of SC/ST/OBC/NT-DT/Minorities/Women etc

17. ADDITIONS TO THE CORPUS:

The Trust Fund may be added to, by the income from the initial fund and also by donations and other contributions from time to time.`

18. INDEMNITY:

The Trustees shall be kept fully indemnified and harmless by the trust against any loss suffered or liability arising against the anything done by them in good faith pursuant to the power and authority conferred on them by this Deed.

19. DISSOLUTION:

In the event of dissolution or winding up of the trust the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees but the same shall be transferred to another charitable, religious, trust, society, association or institution whose objects and faiths are similar to those of the trust and which enjoys recognition u/s 80 G of the Income Tax Act 1961 as amended from time to time.

20. AMENDMENT:

The Trustees has power to amend, alter any clause(s) of the trust deed by passing the resolution in their meeting on the basis of majority decision subject to the compliances of prevailing laws of land. SHAHDARA & SEEMAPURI, DELMI

However, Trustees shall not have power to cancel, amend or alter any provisions of this deed of Trust relating to rights, powers and authorities of the Permanent Trustee or of the present or future Author.

Trustees shall not have power to amend, cancel or alter the type of trustee & number of trustees & also trustees shall not have power to cancel, amend or alter any provisions made in point no. 10 i.e. VOTING PATTERN & point no. 11 i.e. QUORUM.

21. IRREVOCABILITY:

It is declared that the Trust is irrevocable. If the Trust fails for any reason, in the opinion of the Trustees, the net assets of the Trust, both movable and unmovable shall be handed over to any Trust having the same object, as decided by the Author.
